Title: Did Pressman call in two Hungarian judges?

According to our information, the case caused a conflict in court circles; our source assessed the case as gross interference in the Hungarian justice system. The reversed scenario is difficult to imagine: what a scandal it would cause if the Hungarian ambassador in Washington were to invite even a few judges of a state supreme court.

The leading American diplomat might not be aware of the fact that, in one of the NCJ's resolutions, it stated that, based on Article 1 of the Judicial Code of Ethics, "the judge acts without any influence during his judging activities, validating the principle of equal treatment of parties (...)."

Judges in Hungary must be aware that, according to the US State Department's records, its ambassador represents the interests and policies of the United States and in some cases openly politicizes, as we could observe in the case of Ambassador Pressman.

Title: This is interference in our justice system – Parliamentary Committee President on the meeting between the American ambassador and judges

"I am concerned about the case. How is this possible? Our Fundamental Law clearly defines the independence of judges.

What happened is quite astonishing; this move can only be interpreted as interference in the Hungarian judiciary."



Interestingly, even the NJC stated in one of its resolutions that, according to Article 1 of the Judicial Code of Ethics, "a judge shall act free from any influence in his judicial activities, upholding the principle of equal treatment of all parties. In the course of his work, he shall avoid even the appearance that he is favouring anyone or that his actions and decisions are biased or based on prejudice (...) A judge shall refrain from undue connections with the legislative and executive powers in a manner that is obvious to outsiders".

[MP Imre] Vejkey told us that the issue is not on the agenda of the parliamentary body. It is true that the president of the supreme court will soon be heard on the report on the functioning of the Kúria last year, but that will be limited to the year 2021.

Every year, the Committee on Justice hears the annual reports of the NJC, the President of the Kúria, and the Prosecutor General, which are submitted to the Hungarian Parliament. The NJC's report is first discussed by the Committee on Justice, and based on that, a proposed amendment is submitted to Parliament.

At the moment, the 2021 report is being discussed, so we cannot ask a question on this matter, but we will certainly do so regarding the 2022 report.

Title: More leftist threads emerge among those who excuse the Pressman scandal

Judges are mandated to apply the law, not to give political advice, stated Miklós Szánthó, Director General of the Center for Fundamental Rights. Title: Two Hungarys – The party is still on, which is why Judges Vasvári and Matusik were laughing in the Office of the American Ambassador – Briefing for the Viceroy

The latter two are members of the notorious National Judicial Council (NJC). The NJC was set up years ago to oversee the administration of the Hungarian courts. In practice, however, it appears to have been set up as a massively politicised, anti-government coterie, echoing the slogans of the left-liberal parties.

It was this group that quasi-denounced the government to the European Networks of Councils for the Judiciary over its administrative courts plan. And it is the members of this council who regularly complain in the national and Western bourgeois newspapers about the state of public affairs in Hungary and the desperate state of the judiciary.

Zoltán Lomnici Jr.: András Zs. Varga, President of the Kúria, pointed out in his statement that, to his knowledge, the representatives of the judiciary have received and will receive ambassadors in their offices, if they so request. However, the President said he had no information that the relationship between the NJC and the American ambassador had been on the agenda of either of the two October meetings of the NJC. He was also not aware, he continued, that anyone had authorised the members of the NJC to express their critical views to a representative of another country, and anyway, the NJC President should have requested authorisation for the meeting. He also made it clear that ambassadors and envoys are political actors. An ambassador's official title is "Ambassador Extraordinary and Minister Plenipotentiary" or "Ambassador Extraordinary and Plenipotentiary". As part of the executive branch, they act on the instructions of the President, Prime Minister, or Foreign Minister of their own country. In my view, the above-mentioned professional opinion of the President of the highest judicial forum does not need to be supplemented in this respect.

Title: The rebellious judicial body is a reference point in the EU's rule of law reports

We have examined the rule of law reports that have been bandied about in Brussels as an indictment of our country and come to an interesting conclusion. The introduction and the sub-chapter on the judicial independence in last year's document and that of the year before last are in many respects identical. Some paragraphs have been specifically copy-pasted from the 2021 report into the 2022 one. In both years, Amnesty International, the Hungarian Helsinki Committee, and the National Judicial Council provided the ammunition for the changed and unchanged sections.



In November 2020, an astonishing study with the above title was published by Viktor Vadász and his co-author in the German liberal legal forum Verfassungsblog.de, which claims to be respected. Vadász, who was then also an active judge and a member of the NCJ, added his name to ideas such as:

The name of the former judge, Viktor Vadász, also comes up here. Amnesty International's Szilvia Balassa, Judit Kende, and Orsolya Selymes gave a lecture on "Stereotyping, prejudice, discrimination" at the Hungarian Justice Academy. But we also reported that Viktor Vadász must have had a fit of rage when Parliament's Committee on Justice took apart the submission demanding the dismissal of the President of the National Office of the Judiciary (NOJ), and he suddenly tweeted in English that "Tünde Handó = Fidesz". The statement, which might seem like a harmless quip from anyone's pen, is tantamount to a confession from the spokesperson of the National Judicial Council (NJC), suggesting that the unreceptive promoters of judicial independence are actually plotting the fall of the government.

In sum, the parts concerning the NJC of the two documents are about two-thirds identical., so much so that there is hardly any difference in the number of footnotes in the subsection on the independence of the judiciary (2021:61, 2022:60), and the source of the material presenting Hungary in a negative light in both years is Amnesty International, the Hungarian Helsinki Committee, and the judicial council at the organisational level. In neither case was the government or a non-liberal NGOs asked for an opinion on the independence of the judiciary. However, the dates in the footnotes show that the editors worked mostly and in principle from recent materials. This could mean two things: either a number of findings were ignored, or both the NGOs working under their thumb and the NJC sent a minimally updated briefing from last year to the Brussels-Strasbourg bureaucrats.

The whole report, by the way, took into account the views of nearly sixty organisations in 2021, 16 of which have some form of connection with the state or the right. The same in 2022: 11 out of just over forty. This may explain the imbalance. There are many question marks around the EU rule of law report, but one thing seems to be certain: the document, which is being floated as an indictment of Hungary and [justification for] the withholding of funds due to our country, is a pat, the compilation of which is being driven to a decisive extent by organisations supported by the George Soros Open Society network of foundations and the National Judicial Council.

Title: Hungarians reject US interference in domestic politics

It has caused a stir in the Hungarian public discourse that the US Embassy in Hungary published a video on its Twitter page which portrays leading pro-government politicians and various public opinion leaders in a negative light, and that American Ambassador David Pressman held a confidential meeting with two Hungarian judges who are members of the National Judicial Council. A November Századvég poll surveyed Hungarians' opinion on the role of the Embassy of the United States in Hungary's domestic affairs.

The survey shows that Hungarian voters strongly oppose any attempt to interfere with the relationship between Hungary and the United States. In contrast, they overwhelmingly support the maintenance of friendly relations based on respect for diplomatic rules.

Accordingly, more than three quarters of Hungarians (76 percent) believe that the United States should maintain a relationship with Hungary based on partnership and respect for diplomatic rules, and refrain from interfering in the country's internal affairs.

The proportion of those who think that the US should play an active role in Hungarian domestic politics, and that the US should criticise the Hungarian government if it deems it necessary, is 18%.

Similarly, nearly two-thirds of respondents (65 percent) disagree with the US Embassy directly expressing its views on Hungarian domestic policy issues, while 31 percent approve.
